#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Veterans Education

5 Experience Improvement Act of 2017".

#### 6 SEC. 2. TRAINING FOR SCHOOL CERTIFYING OFFICIALS.

7 (a) TRAINING REQUIREMENT.—The Secretary of8 Veterans Affairs shall, in consultation with the State ap-

proving agencies, set forth requirements relating to train-1 ing for school certifying officials employed by covered edu-2 3 cational institutions offering courses of education ap-4 proved under chapter 36 of title 38, United States Code. 5 (b) DISAPPROVAL.—If a covered educational institu-6 tion does not ensure that a school certifying official em-7 ploved by the educational institution meets such require-8 ments, the Secretary may disapprove any course of edu-9 cation offered by such educational institution.

# 1SEC. 3. LIMITATION ON NUMBER OF CERTIFICATIONS2MADE BY SCHOOL CERTIFYING OFFICIALS.

3 (a) IN GENERAL.—The Secretary of Veterans Affairs shall, in consultation with the State approving agencies, 4 5 set forth requirements for covered educational institutions offering courses of education approved under chapter 36 6 7 of title 38, United States Code, to employ one school certi-8 fying official for every 500 unduplicated certifications 9 made during a fiscal year. If a covered educational institu-10 tion does not ensure that enough school certifying officials 11 are employed by the educational institution to meets such 12 requirements, the Secretary may disapprove any course of 13 education offered by such educational institution.

14 (b) DEFINITIONS.—In this section:

(1) COVERED EDUCATIONAL INSTITUTION.—
The term "covered educational institution" means
an educational institution that has enrolled 20 or
more individuals using educational assistance under
title 38, United States Code.

 SEC. 4. LIMITATION ON USE OF REPORTING FEES PAYABLE
 TO EDUCATIONAL INSTITUTIONS AND JOINT

### APPRENTICESHIP TRAINING COMMITTEES.

6 (a) IN GENERAL.—Section 3684(c) of title 38,
7 United States Code, is amended to read as follows:

((c)(1)) The Secretary may pay to any educational in-8 9 stitution, or to the sponsor of a program of apprenticeship, 10 furnishing education or training under either this chapter or chapter 31, 34, or 35 of this title, a reporting fee which 11 12 will be in lieu of any other compensation or reimbursement 13 for reports or certifications which such educational institution or joint apprenticeship training committee is required 14 15 to submit to the Secretary by law or regulation.

16 "(2) Such reporting fee shall be computed for each 17 calendar year by multiplying \$16 by the number of eligible 18 veterans or eligible persons enrolled under this chapter or 19 chapter 31, 34, or 35 of this title. The reporting fee shall 20 be paid to such educational institution or sponsor of a pro-21 gram of apprenticeship as soon as feasible after the end 22 of the calendar year for which it is applicable.

"(3) No reporting fee payable to an educational institution under this subsection shall be subject to offset by
the Secretary against any liability of such institution for

any overpayment for which such institution may be admin istratively determined to be liable under section 3685 of
 this title unless such liability is not contested by such in stitution or has been upheld by a final decree of a court
 of appropriate jurisdiction.

6 "(4) Any reporting fee paid to an educational institu-7 tion or joint apprenticeship training committee after the 8 date of the enactment of the Post-9/11 Veterans Edu-9 cational Assistance Improvements Act of 2011 (Public 10 Law 111-377)—

"(A) shall be utilized by such institution or
committee solely for the making of certifications required under this chapter or chapter 31, 34, or 35
of this title or for otherwise supporting programs for
veterans; and

"(B) with respect to an institution that has 75
or more enrollees described in paragraph (2), may
not be used for or merged with amounts available
for the general fund of the educational institution or
sponsor of a program of apprenticeship.

21 "(5) The reporting fee payable under this subsection
22 shall be paid from amounts appropriated for readjustment
23 benefits.".

24 (b) EFFECTIVE DATE.—The amendment made by25 subsection (a) shall take effect on August 1, 2018.

"(2) In selecting locations for the provision of counseling services under this section, the Secretary shall seek
to select locations where the maximum number of veterans
would have access to such services.

14 "(c) ANNUAL REPORT.—Not later than 180 days 15 after the date of the enactment of this section and not 16 less frequently than once each year thereafter, the Sec-17 retary shall submit to Congress a report on the counseling 18 services provided under this section. Such report shall in-19 clude, for the year covered by the report—

"(1) the average ratio of counselors providing
such services to veterans who received such services
at each location where such services were provided;
"(2) a description of such services provided;
